Review Comments and Questions on Type B Water Licence Renewal Application for Shell Canada Limited (N7L1-1762)

Introduction

The comments and questions provided herein are based on a completeness review of the Type B Water Licence renewal application for Water Licence N7L1-1762. The review was based on the merit of the renewal application alone.

In filing a renewal application, the applicant must meet the requirements of the Northwest Territories Waters Act, and the Northwest Territories Waters Regulations, with particular attention to (but not limited to):

- Schedule III application form contained in the Northwest Territories Waters Regulations;
- Sections 6 and 7 of the Northwest Territories Waters Regulations;
- Section 17 of the Northwest Territories Waters Act; and,
- NWT Water Board Water Licence Application Questionnaire for Municipal Undertakings.

The following provides general review comments and questions related to overall deficiencies in the application.

The application is lacking the detailed information required to process a water licence renewal application. The following clarifications are needed in order to complete your application.

Schedule III Application information requirements:

Section three (3) 'Location of Undertaking'

No maps were submitted with the renewal application. Please refer to existing maps that had already been submitted in one of your previous application or submit new maps to the NWT Water Board.

When applicable, the maps should indicate the location of watercourses, the location of any proposed waste deposits, the raw water intake, the water treatment facilities, the fuel and chemical storage, the sewage treatment facilities, the wastewater treatment area and discharge outlets, the solid waste disposal areas and drainage patterns, the location of hazardous waste disposal area, the transportation access routes and the location of environmental monitoring sites.

Section four (4) 'Description of Undertaking'

This section refers to attached documents. The supporting project description document (a letter dated of September 29, 2010, submitted by IEG Consultants on which you were c.c.) does not describe the capacity of the Camp. Please clarify the description of undertaking by submitting the capacity of the Camp.

Section seven (7) 'Quantity of Water Involved'

It is mentioned in this section "... and the Unnamed Lake to the north in the summer." Please submitted the missing information; to the north of what?

Also, it is mentioned in this section that treated wastewater will be discharged to the Mackenzie River (150 cubic metres per day) provided discharge criteria are met. Please clarify which criteria Shell Canada Limited will respect before discharging wastewater.

Section eight (8) 'Waste Deposited'

This section requires more information with respect to waste including, but not limited to:

- description of any and all wastes produced and methods of disposal is incomplete (i.e. missing the disposal of solid waste, how is the waste transported to the Inuvik facilities, how is the waste stored in Camp, how long is the waste stored in Camp)
- Does the town of Inuvik approve the disposal of waste from Camp Farewell in their facilities?
- Is the quantity of effluent to be deposit per day, per month or per year?
- description of any proposed methods for waste storage
- list of hazardous materials to be used and stored on site
- methods for handling, storage and disposal of hazardous material
- plans for abandonment and/or temporary closure of fuel and hazardous waste storage facilities

Solid Wastes:

- Do you plan on storing solid waste on site? If yes, where, in what quantities and for how long? Do you plan on removing stored wastes to a third party facility? If yes, which facility. Please provide proof of authorization from this facility. How often do you plan to remove solid wastes from Camp Farewell to a third party facility? How do you plan on removing solid wastes from Camp Farewell?
- Do you plan on disposing of solid wastes on site? If yes, where and in what quantities?

Wastewaters:

- Do you plan on storing wastewaters on site? If yes, where, in what quantities and for how long? Do you plan on removing stored wastes to a third party facility? If yes, which facility. Please provide proof of authorization from this facility. How often do you plan to remove solid wastes from Camp Farewell to a third party facility? How do you plan on removing wastewaters from Camp Farewell?
- Do you plan on disposing of wastewaters on site? If yes, where and in what quantities?

Hazardous Wastes:

- Do you plan on storing hazardous waste on site? If yes, where, in what quantities and for how long? Do you plan on removing stored wastes to a third party facility? If yes, which facility. Please provide proof of authorization from this facility. How often do you plan to remove hazardous wastes from Camp Farewell to a third party facility? How do you plan on removing hazardous wastes from Camp Farewell?
- Do you plan on disposing of hazardous wastes on site? If yes, where and in what quantities?

Sewage:

Do you plan on storing sewage waste on site? If yes, where, in what quantities and for how long? Please provide proof of authorization from the Town of Inuvik for the disposal of sewage. How often do you plan to remove solid wastes from Camp Farewell to a third party facility? How do you plan on removing sewage wastes from Camp Farewell?

Please submit the above information. If it already exists, please refer to the document (and pages, if applicable) where the NWT Water Board can find the information.

Also, in the supporting project description document (a letter dated of September 29, 2010, submitted by IEG Consultants on which you were c.c.) it is mentioned that the "sewage lagoon is no longer used for disposal of waste water. All wastewater that may now be generated by Camp operations is removed from the site for disposal in Inuvik". In Schedule III it is mentioned that "sewage and greywater to be treated using the existing Extended Aeration Sewage Treatment System. The effluent discharged to the Mackenzie River will comply with the effluent quality requirements..." Please provide clarification on this matter, since it appears the documents contradict.

Section ten (10) 'Predicted Environmental Impacts of Undertaking and Proposed Mitigation'

The renewal application does not describe the predicted environmental impacts nor does it identify mitigation measures for potential environmental impacts. Please refer to existing documentations submitted to the NWT Water Board by Shell Canada Limited regarding the prediction of environmental impacts and mitigation measures or submit a new document in that regards to the NWT Water Board.

Section eleven (11) 'Contractor and sub-contractors'

Will a list of contractor and/or sub-contractors working at Camp Farewell be forwarded to the NWT Water Board once available?

Application Fee

Please submit the renewal application fee payable to the Receiver General.

Security Deposit

Please, submit a proof that the security deposit will be maintained in accordance with section 17 of the Northwest Territories Waters Act.

NWT Water Board Water Licence Application Questionnaire for Municipal Undertakings

At a minimum, the following information is required:

- Descriptions of the freshwater intake facility
- Descriptions of the operating capacity of the pump used
- Descriptions of the type of water storage facility
- The capacity of the storage facility (m³)
- The effects on the river or lake from which water will be drawn
- The capacity of the treatment facility
- Type of water treatment facility
- Describe in detail the method of water treatment (i.e. backwash, flocculation, sedimentation, chemicals used)
- Have there been any problems or health and environmental concerns with the water treatment facilities?
- Are there any changes planned in the water treatment facilities?
- List and describe the locations of abandoned or restored sewage treatment facilities
- Briefly describe the methodology that is presently used to sample the raw water supply
