Hi Joshua,

It was nice to have a brief conversation with you.

Basically as we spoke – Pb concentration pre-treat < post-treatment. I suspect there should be systematic error. Also note that Pb effluent quality criteria depend on the hardness. In the case of municipal storm water drainage system, non-point pollutants entering into the system depends on various factors such as availability, storm intensity, season etc. therefore, this can't be considered background in comparison with the contaminated water collected from the contaminated soil treatment facility.

Matrix Solutions Inc., on behalf of NTPC, requested for the amendment (as indicated in email below from Matrix) of the NTPC Miscellaneous Water Licence N3L8-1838. Upon review of the amendment request and water licence Terms &

Conditions, it appears that water that does not meet the effluent criteria should be transported and disposal at licenced facility as specified by Water Licence N3L8-1838 Part C, Item 9:

"The Licensee shall dispose of all contaminated water that does not meet effluent criteria at a licenced disposal facility";

Prior to shipment, copies of agreement or letter should be provided to the Board as required by Water Licence N3L8-1838 Part C, Item 11:

"Where contaminated soils and/or water is to be transported to a licenced disposal facility, the Licensee shall provide to the Board, prior to shipment, copies of agreements or letters between the Licensee and the third parties where the third party has agreed to harbour, transport or dispose of such contaminated water and/or waste".
