## RE: RENEWAL APPLICATION - N5L3-0714 HAMLET OF TUKTOYAKTUK

Dear Ms. Semmler:
The Environmental Impact Screening Committee (EISC) has the responsibility to screen proposed developments within the Inuvialuit Settlement Region and you as a Competent Authority may issue a licence, permit or other authorization that would authorize in whole or in part the carrying out of a development. This includes any revisions to the original project.

Section $11(36)$ states "No licence or approval shall be issued that would have the effect of permitting any proposed development to proceed unless the provisions of this section have been complied with".

In the case of government projects undertaken within the municipal limits of a community located in the Inuvialuit Settlement Region, the EISC must first determine whether or not the activities would directly affect wildlife resources outside the municipal limits as stated in the Inuvialuit Final Agreement's definition of 'Development'.

In order for the Environmental Impact Screening Committee to fulfil its mandate with respect to the proposed revisions outlined in the renewal application submitted to the Inuvialuit Water Board, the Proponent is required to submit a project file to the EISC Registry for to determine whether or not the activities would affect wildlife resources outside the municipal limits.
