Re: Water Licence N7L1-1834 Shell Canada Energy, Farewell Camp and Stockpile Site (Camp Farewell) – 2014 Decommissioning Program Report

The Inuvialuit Water Board (IWB) acknowledges receipt of the above mentioned annual report for Shell Canada Energy along with a cover letter dated April 9, 2015 submitted by IEG Consultants Ltd. The IWB reminds you that an annual report should be filed with the Board not later than March 31<sup>st</sup> of the year following the calendar year reported. Upon review of the report, information gaps were noted as required by General Conditions Part B, Item 1 of the Water Licence. To address these information gaps please provide the following:

- 1. As required by Part B, Item 1a, provide the monthly and annual quantities in cubic metres of fresh water obtained from all sources.
- 2. In accordance with Part B, Item 1e, provide the results of sampling carried out under the "Surveillance Network Program".
- As required by Part B, Item 1f, provide a summary of any Modifications carried out on the Water Supply Facilities and Sewage Treatment Facilities, including all associated structures.
- 4. As required by Part B, Item 1g, provide a list of any spills and unauthorized discharges.
- 5. As per Part B, Item 1i, provide an outline of any work anticipated for the next year.
- 6. In accordance with Part B, Item 1j, provide a summary of any studies requested by the Board that relate to Waste disposal, water use or reclamation, and a brief description of any future studies planned.

- 7. As per Part B, Item 1k, provide any updates and/or revisions to the plans as mentioned i.e. Spill Contingency Plan, Waste Disposal Facilities Operations and Maintenance plan, and Sewage Treatment Plan.
- 8. As required by Part B, Item 1I, provide an outline of any spill training and communications exercises carried out.
- 9. As required by Part B, Item 1m, provide any other details on water use or Waste disposal.

The submitted report including the IWB response will be placed on the IWB Public Register.
