Hi Fred,

Although I cannot clearly see the extent and quality of the clean up of the sewage in the photo that you provided me, I would like to thank you for your quick response last week. Luckily that amount of sewage was released only at the sewage disposal site.

Importantly, I had a look through the Aklavik's most recent water license inspection report and on the second page of the September 2017 inspection report, it reads that there was evidence of sewage being discharged outside of the disposal chute. It seems like this has been a long on-going issue. Please come up with a solution to have this issue remediated as soon as possible.

Also, I ask again if can you please have one of your staff or one of your contractors report the spill so that we have this on file. This may not have been enforced previously but I would like to have these things recorded, especially when there is a water license with annual reporting involved. This event should also be included in your April 30th annual report, as stated in Section Part B 1(f) of your water license N3L3-0570.

Remember, as a water license holder, it the Hamlets responsibility to report these occurrences, as stated in your O&M Plan and your Spill Contingency Planning (updated 2014).

Hi Fred,

Today I received a photo of the condition of the sewage chute and surrounding area down at Aklaviks lagoon. It appears as though the operator is missing the chute quite a bit when unloading.

The amount of coloration on the snow heap directly below the chute indicated to me that this has been an on-going issue and isn't a one time spill event.

Can you confirm if the company that is contracted to deal with the sewage is in fact Mackenzie Delta Holdings Ltd. with Eddie Greenland?

Can you also have your contractors (the responsible party) to report this sewage spill to the spill line and have them clean-up the spill immediately, to eliminate the spread of fecal bacteria, possible illnesses and diseases and all else that comes with exposed sewage.

To give you guys enough time, I will have Ian inspect the location on Monday, January 14th at 17:00. I hope that this is more than enough time to have this completed. If 5 days is not enough time to have this sewage cleaned up, please let me know and we can discuss another date that works better for you.

If funding is needed for maintenance for equipment, feel free to let either myself or Lloyd know and we can try to find out what, if anything, is available for municipalities.
