Attached is an amended cover to Water Licence N7L3-0714 granted to the Hamlet of Tuktoyaktuk by the Northwest Territories Water Board (the Board) in accordance with the Northwest Territories Waters Act. A copy of this Licence has been filed in the Public Registry at the Northwest Territories Water Board offices in Inuvik and Yellowknife.

Water Licence N7L3-0714 has been amended to reflect a requested extension by the Hamlet of Tuktoyaktuk. The amended expiry date for the Water Licence is now December 29, 2009. No conditions of the licence have been changed and the Hamlet is to continue to abide by these conditions until a licence renewal has been issued. The Board expects the Hamlet of Tuktoyaktuk to provide a renewal application at your earliest convenience.
