Issue/Question/Comment	Response by Shell/IEG		
Aklavik HTC, Community Corporation, Elders, and Public (Joint Meeting)			
	Shell: We would like your input on whether the emergency shelter should stay at Camp Farewell or not. Let us know and we will do what you want with it.		
Can you send a list to the HTC describing what is required on this project?	Shell: Yes, we'll make that a standard practice in terms of service and labour.		
Inuvik HTC			
	Shell: We would like your input on whether the emergency shelter should stay at Camp Farewell. If you want it to stay, then Shell's happy to leave it. If you don't want it to stay, then we'll remove it.		
I suggest the emergency shelter stays at Camp Farewell. It makes sense if its there already. Does it have a wood stove?	IEG: Yes, it has a wood stove.		
It's for emergency and our members do use it. It helps out the community.	Shell: We'll plan on leaving it. We can talk about what needs to be done to make it useful.		
Will you maintain the airstrip? Grade it or anything?	Shell: If we needed to, and if we have the equipment there, we could do it. We wouldn't bring a grader to site just for that.		
What about using a bucket loader?	Shell: Sure.		
There might be cracks going across it. It's good to have a runway to land on in case there's ever an emergency.	Shell: We can take a look at it, to the extent that there's no major repair required. We don't want to import material. We don't build air strips and we wouldn't want to make a mistake. Major repairs to the airstrip puts a lot of liability on Shell. If its just running up and down with a tractor and bucket, we could do that, but major repairs we can't.		
There's some slumping right at the bank where the lagoon was. Are you guys keeping track of how much erosion is going on in that area?	Shell: We monitor every year. If it gets to the lagoon, we have remediated it so it won't cause an environmental problem. We will continue monitoring. The same thing is happening at Unipkat I-22. It's going to erode.		
The ice hits that bank in the spring. Is it a steady state of erosion or is it elevated because of the remediation?	Shell: We haven't been officially or formally monitoring it. We have been monitoring it visually.		
I pass by there every year. This year it was nice to see that everything was cleaned up. It's really good that you guys are cleaning up.	Shell: Thank you.		
Are you going to find out who the actual owner of the barge moorings is?	IEG: We've talked to Department of Fisheries and Oceans (DFO), they were going to get back to us. It may be a DFO issue and not a Shell issue but were waiting for clarification on that.
