Hi Mardy and Bijaya,

The approved screening in 2012 was for the water licence application only, it does not include projects conducted under the water licence. The water licence and the subsequent projects under the water licence are two different things. Because the details of the water licence amendment application remain the same as the original application submitted in 2012, the EISC was able to extend the water licence application approval (the attached letter originally forwarded to EISC on June 15, 2017). This approval however does not dismiss Shell from completing the questionnaire and project descriptions for future projects at Camp Farewell. The water licence application and proposed projects under the application are treated separately.
