Re: N7L3-1531 - Hamlet of Sachs Harbour, Municipal Water Licence - 2020 Annual Report Additional Information Request

The Inuvialuit Water Board (IWB) acknowledges receipt of the 2020 Annual Report received on May 13, 2021. Upon review, numerous information gaps were noted. Please re-submit the 2020 Annual Report with the following information as per water licence N7L3-1531:

1. Part B, Item 1 c): a summary of the monthly and annual quantities of hazardous waste stored on site and transported off site including the location and treatment, or disposal plans for the remaining quantities on site.
2. Part B, Item 1 d): the monthly and annual quantities of sewage sludge removed from the Sewage Waste Disposal Facilities and disposal location.
3. Part B, Item 1 e): any problems, modifications or repairs done to the Water Supply and Waste Disposal Facilities, including all associated structures.
4. Part B, Item 1 f): tabular summaries of all data generated under the "Surveillance Network Program (SNP)" sampling stations 1531-2 (effluent discharge from existing sewage disposal facilities) and 1531-3 (run-off from existing solid waste disposal facilities).
5. Part B, Item 1 g): a list of spills and unauthorized discharges.
6. Part B, Item 1 h): a description of any spill training and/or other operator training carried out.
7. Part B, Item 1 i): a description of any Closure and Reclamation work completed during the year and an outline of any work anticipated for the next year.
8. Part B, Item 1 j): a description of any studies requested by the Board that relate to water use, waste disposal or closure and reclamation and a brief description of any future studies planned.

9. Part B, Item 1 k): any updates and/or revisions to the:
- approved Spill Contingency Plan
 - approved Solid Waste Disposal Facilities Operation and Maintenance Plan
 - approved Sewage Waste Disposal Facilities Operation and Maintenance Plan
 - approved Hazardous Waste Management Plan, and
 - approved Closure and Reclamation Plan.
10. Part B, Item 1 l): results of staff inspections on all Water Use and Waste Disposal Facilities including all dams, berms, dykes and control structures authorized under this licence and any corrective actions, as necessary.
11. Part B, Item 1 m): the inclusion of all correspondence between the inspector and the Licensee, and
12. Part B, Item 1 n): any other details on waste disposal requested by the Board by November 1 of the year being reported.
