Re: N5L3-0714 Hamlet of Tuktoyaktuk, Municipal Water Licence ~ 2022 Annual Report

The Inuvialuit Water Board (IWB) acknowledges receipt of N5L3-0714 Hamlet of Tuktoyaktuk Municipal Water Licence 2022 Annual Report on June 30, 2023. The IWB appreciates the Hamlet of Tuktoyaktuk's submission of the annual report. Upon review, information gaps have been identified. As per the Hamlet of Tuktoyaktuk's Municipal Water Licence N5L3-0714, please provide the following information:
