**Re: N7L3-1531 - Hamlet of Sachs Harbour, Municipal Water Licence Renewal Application**

The Inuvialuit Water Board (IWB) received the above-mentioned renewal application on September 16, 2022. The IWB has completed an initial review of the application and as a result, further information / clarifications are required for the IWB to continue with the application renewal process. Please provide the following additional information / clarifications.

**1. Water Licence application - Schedule C:**

- a. Section 2. Information is not provided under this section. Provide the address of head office in Canada if incorporated. If this section is not applicable, provide the response as follows:  
"This section is not applicable or N/A."
- b. Section 7. The Hamlet has indicated that the quantity of water involved 4,800 m<sup>3</sup>. Is the quantity of water involved 4,800 m<sup>3</sup> per year? Please clarify.
- c. Section 12. Response is not provided under this section. Describe the studies undertaken to date. If no studies to date, provide the response as follows:  
"No studies undertake to date."

**2. Solid Waste Disposal Facilities Operation and Maintenance Plan:**

- a. The Hamlet of Sachs Harbour submitted a revised Solid Waste Disposal Facilities O&M Plan on October 16, 2020; and additional information on January 26, 2021. The Board approved the plan on February 1, 2021.

Please provide the above-mentioned additional information / clarifications to the IWB by **September 30, 2022** for the IWB to continue processing the renewal application in a timely manner. **Please note that above requested additional information /c larifications can be provided to the IWB in letter form there is no need to re-submit a Water Licence Renewal Application Schedule C as the original was submitted on September 16, 2022.**

As mentioned in the cover letter submitted by the Hamlet, a Project Summary Questionnaire (PSQ) has been submitted to the Environmental Impact Screening Committee (EISC). Once the EISC decision is available to the Hamlet, please provide to the IWB.
