## RE: N5L3-0714 Hamlet of Tuktoyaktuk – Municipal Water Licence Renewal Application

The Inuvialuit Water Board (IWB) acknowledges receipt of the Hamlet of Tuktoyaktuk Water Licence Renewal Application package on October 18, 2023. The IWB has completed an initial review of the water licence application and supporting documents, and as a result, additional information is required to continue with the application renewal process. Please provide the following information:

## A. Spill Contingency Plan:

- 1. Page 1, section 1.1 Verify and update email tuksao@northwestel.net SAO@tuktoyaktuk.ca. Include contact information for Katrina Cockney, Acting SAO, Email: ASAO@tuktovaktuk.ca or designates.
- 2. Page 1, section 1.3 Verify and update the distribution list with current information, including:
  - a. Clarify whether the Department is "Environment Canada" or "Environment and Climate Change Canada. Update with current information.
  - b. The GNWT Department of Environment and Natural Resource (ENR) and Department of Lands (DoL) have amalgamated and renamed as Department of Environment and Climate Change (ECC). Replace references of "Government of the NWT - Lands Division" with "Government of NWT, Department of Environment and Climate Change (ECC) - Lands and Waters Division, Beaufort Delta Region".
  - c. Replace "Government of the NWT ENR Water Resources" with "Government of NWT, Department of Environment and Climate Change (ECC) - Lands and Waters Division, Beaufort Delta Region". Also replace the second column "phone: (867) 687-6652" with "Phone: 867-678-8090 ext. 24659".
- 3. Page 13, section 1.12.2, paragraph 5, line 2 clarify whether it is "Aboriginal and Northern Development Canada (AANDC)" or "Crown-Indigenous Relations and Northern Affairs Canada (CIRNAC)". Verify and update with the current information.
- 4. Page 15, section 2.1, Table 7 Verify and update the table (Organization, Contact and Phone Numbers) with the current information, including:

- 5. Page 15, section 2.2 replace "GNWT ENR" with "GNWT ECC".
- 6. Page 15, section 2.2 If the public may be impacted by a spill include notification procedures to alert the public.
- 7. Page 16, section 2.4, bullet 1 Replace "The GNWT, Department of Environment and Natural Resource (ENR)....." with "The GNWT, Department of Environment and Climate Change (ECC)...".
- 8. Page 16, section 2.4, bullet 2 Canada Energy Regulator (CER) has replaced the National Energy Board (NEB). Therefore, replace "NEB" with "CER".
- 9. Page 16, section 2.5, bullet 1 Replace "ENR" with "ECC".
- 10. Page 16, section 2.5, bullet 4 Replace "NEB" with "CER".
- 11. Page 26, section 4.1 Include a statement "For the operator's convenience and increased environmental protection, all heavy equipment and refuelling vehicles will carry portable spill kits that include items such as absorbent pads, containment booms, and spill pool catchment receptacles. Readily available and fully stocked spill kits can effectively mitigate potential spills."
- 12. Page 27, section 4.2, Table 9 This table needs to be updated with the current information, including:
  - a. Replace "GNWT Environment and Natural Resource" with "GNWT Department of Environment and Climate Change".
  - b. Update phone numbers in column 3 ie: phone number of GNWT ECC Lands and Waters Division, Beaufort Delta Region, Water Resource Officer (Inspector) is 867-678-8090 Ext 24659.
  - c. phone number of Superintendent, Lands and Waters Division, GNWT ECC Beaufort Delta Region is 867 678 8090 Ext 24615.
  - d. Verify all the three columns (Contact, Location/Contact and Phone Number) and update accordingly.
  - e. Comments provided by the ECCC during 2018 Tuktoyaktuk Municipal Water Licence Renewal: "Environment and Climate Change Canada (ECCC) Regional Directorate is no longer a primary point of contact. The new contact is through the NWT/NU 24 Hour spill report line (867 920 8130). The contact number of ECCC provided in Table 9 Section 4.2 is no longer valid and needs removal". Verify and update Table 9 accordingly.
  - f. Comments provided by the ECCC during 2018 Tuktoyaktuk Municipal Water Licence renewal: "Include ECCC Environmental Enforcement at 867-669-4730 for information relating to the environmental enforcement and reporting requirements under the Canadian Environmental Protection Act and the Fisheries Act". Verify and update Table 9 accordingly.
- 13. Page 28, section 5 Include a description of the record keeping procedures that will document employees who have received training and when.

Include a cover letter and a summary table indicating how and where (e.g., page and section numbers) the requested information is addressed. This will assist the IWB with the continuation of processing your water licence renewal application in a timely manner.
